We take privacy very seriously at AssessCAT. Our privacy policy communicates how we treat personal information. Please read this Policy carefully.

This Policy's defined terms have the same meaning as in our Terms of Service, which You should read together with this Policy. By accessing our Website and using Your Subscription, You consent to the terms of this Policy and agree to be bound by it and our Terms of Service.

#### 1. What information do we collect?

We may collect, store and use the following kinds of personal data:

- information about your visits to and use of this website;
- information that you provide to us for the purpose of registering and/or subscribing to our services.

#### 2. Information about website visits

We may collect information about your computer and your visits to this website such as your IP address, geographical location, browser type, referral source, length of visit and number of page views.
